Deepening relations with UAE a priority of our foreign policy: Ukrainian Prez

kraine can and will be the guarantor of food security to the UAE, according to Ukrainian President Volodymyr Zelenskyy, who is on an official visit to the UAE.

Zelenskyy, 43, the youngest president in Ukraine's history, explained that traditional areas of cooperation have already been developed with agro-industrial products being the main exports from Ukraine to the UAE. "Indeed, Ukraine can and will be the guarantor of the food security of the Emirates. Ukrainian black soils are well known all over the world, we are among the world leaders in the export of wheat, corn and barley," stressed the president.

The Ukrainian food exports to the UAE were valued at \$252.2 million in 2019, majorly constituting sunflower oil, rapeseed, eggs, poultry and wheat flour, according to the Ukrainian Embassy in Abu

Even the Ukraine pavilion at Expo 2020 Dubai will symbolise the idea of food security, the president revealed. "The architectural design of the pavilion embodies the idea of a wheat ear. Wheat is an important symbol for Ukrainians and the yellow colour on our flag symbolises the wheat field and readiness to contribute to world food security," he said.

Zelenskyy commended the UAE's "incredible efforts to fight coronavirus, not only at home but also abroad". "The UAE provided assistance to many countries around the world and Ukraine will not forget the Emirati airplane, which so timely and with friendly warmth delivered humanitarian aid to confront Covid-19 and the UAE helped many Ukrainians to get back home," he added.

The Ukrainian president was referring to the aid plane that was

sent to his country in April 2020, carrying 11 metric tonnes of medical supplies, benefitting 10,000 healthcare professionals. 113 Ukrainian citizens were also repatriated on that flight.

"We consider expanding bilateral relations with the Emirates as a priority of our foreign policy. We are gradually moving to expand the horizons of our relationship by putting more and more ambitious projects on the agenda," he said.

Zelenskyy pointed out to a "successful" example of attracting Emirati investments into the Ukrainian market, which is DP World's operation of a container terminal in the Odessa region in the south of Ukraine. - Wam

UAE crosses 5m milestone in vaccination campaign

he rate of distribution of doses has climbed consistently since the launch of the drive in December last year. Considering all these parameters, it is safe to assume that more than 1.5 million of the population are fully vaccinated. The UAE plans to vaccinate half the population by March.

Despite the success of the vaccination drive, the number of new cases remaining high had been worrisome. However, Saturday marked the fourth day when a decline in positive cases was recorded: 3,539 (Wednesday), 3,525 (Thursday), 3,307 (Friday) and 2,631 (Saturday). It is too early to call it a trend as the figures have surged from this point in the past weeks. Meanwhile, there were 15 deaths and 3,589 recoveries on Saturday.

Dr Saheer Sainalabdeen, specialist respiratory medicine, Medeor Hospital, Dubai, said the government's efforts to crack down on violators will ensure the number of new cases remain under control.

"The UAE is at the forefront in vaccinating the population. Despite these efforts, the current surge in the number of infections and deaths need to be taken seriously. It seems that the public had lowered the guards with the easing of restrictions. However, the government's decision to act tough on lawbreakers would help in bringing the situation under control. Massive vaccination drives and stricter rules would bring the curve down," he said.

2 held for 'showing off' **Covid-19 positive** result in viral video

wo UAE youths have been ordered jailed after one of them roamed around in a public area, 'showing off' his Covid-positive result. The other youth filmed the whole act and posted the video on social media, after which it went viral.

Taking cognizance of the viral video, the Abu Dhabi Public Prosecution ordered that the youths be imprisoned, pending further investigation. They will stand trial for endangering public health and violating Covid-19 safety measures.

The prosecution said that it investigated the clip, identified the youths and ordered their arrest. Under the law, they can be punished with a fine of Dh10,000 to Dh50,000 and/ or imprisonment.

The authority stressed that it will deal with such reckless behaviour with zero tolerance. It called on residents to follow all Covid safety measures.

On February 11, the Dubai Police, in cooperation with the Dubai Economy, shut down an establishment that held a gathering and issued a Dh5,000 fine against it on Thursday for not adhering to Covid-19 precautionary measures. Additionally, each person present at the event was fined Dh3,000 for not wearing a mask and adhering to social

distancing. The Dubai Police also fined a tour operator Dh50,000 for organising an outdoor

Proper double-masking will protect from Covid-19: Docs

Tearing properly-fitted surgical masks or doubling up on masks, can significantly reduce Covid-19 transmission and slow the spread of new, more contagious strains, according to the UAE doctors.

The Centre for Disease Control (CDC) report underscore the finding that a good fit can increase overall mask efficiency, they added. "This CDC study compared wearing no mask, a poorly fitted surgical mask, clothonly mask and double-masking in a simulation of respiratory droplets between two people - a source and a receiver. The study found when people wear a wellfitted surgical mask covered by a cloth mask they can increase their own protection from aerosol droplets by 95 per cent or more,' said Dr Shipra Rai specialist internal medicine, Prime Medical Centre - Al Qasimia.

Dr Zeeshan Anwar, general practitioner, Aster Rafa Poly Clinic - International City, added: "One has to start with a surgical mask and put a cloth mask on top of it. It gives an excellent filtration blocking respiratory droplets and reducing exposure, especially when we have new Covid mutations around the globe."

Protecting the nose from any pathogen entry is of paramount importance in preventing the disease. "Double masking will give us additional protection as Covid-19 the common portal of entry is through the nose. So, the face mask should be kept above the nose. Many times, we see people covering the mouth only, not the nose then there is no point



MOST MASKS NOT MEDICAL GRADE

Most disposable masks in the consumer market are not medical grade, but they are still made of polypropylene, a nonwoven fabric that electrostatically repulses viral particles.

This means they still score high marks when it comes to blocking the virus, say medics. The problem is loose-fitting masks may leave gaps where viral particles can get in and out when worn alone.

"Whether wearing two masks would offer better

protection or reduce the transmission of Covid-19 depends on the type of the face mask. There are different types of face masks available of which, N95 is known to be the best and offers maximum protection. The N95 mask blocks 95 per cent of the particles. So if a person is wearing an N95 mask, then there is no need for an additional one," said Dr Alaa Zedan, specialist internal medicine, Burjeel Hospital for

masks or two cloth masks."Don't combine two disposable masks because disposable masks are not designed to fit tightly and wearing more than one will not improve fit. Also don't layer another mask on top of N95 or KN95, these should be used alone," said Dr Anil Grover specialist internal medicine, Prime Hospital.
