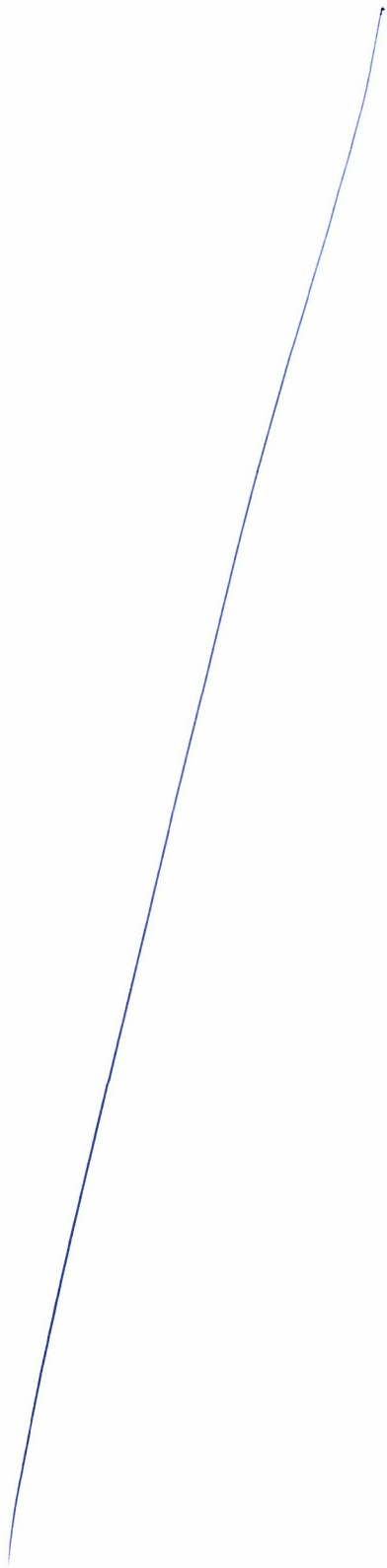
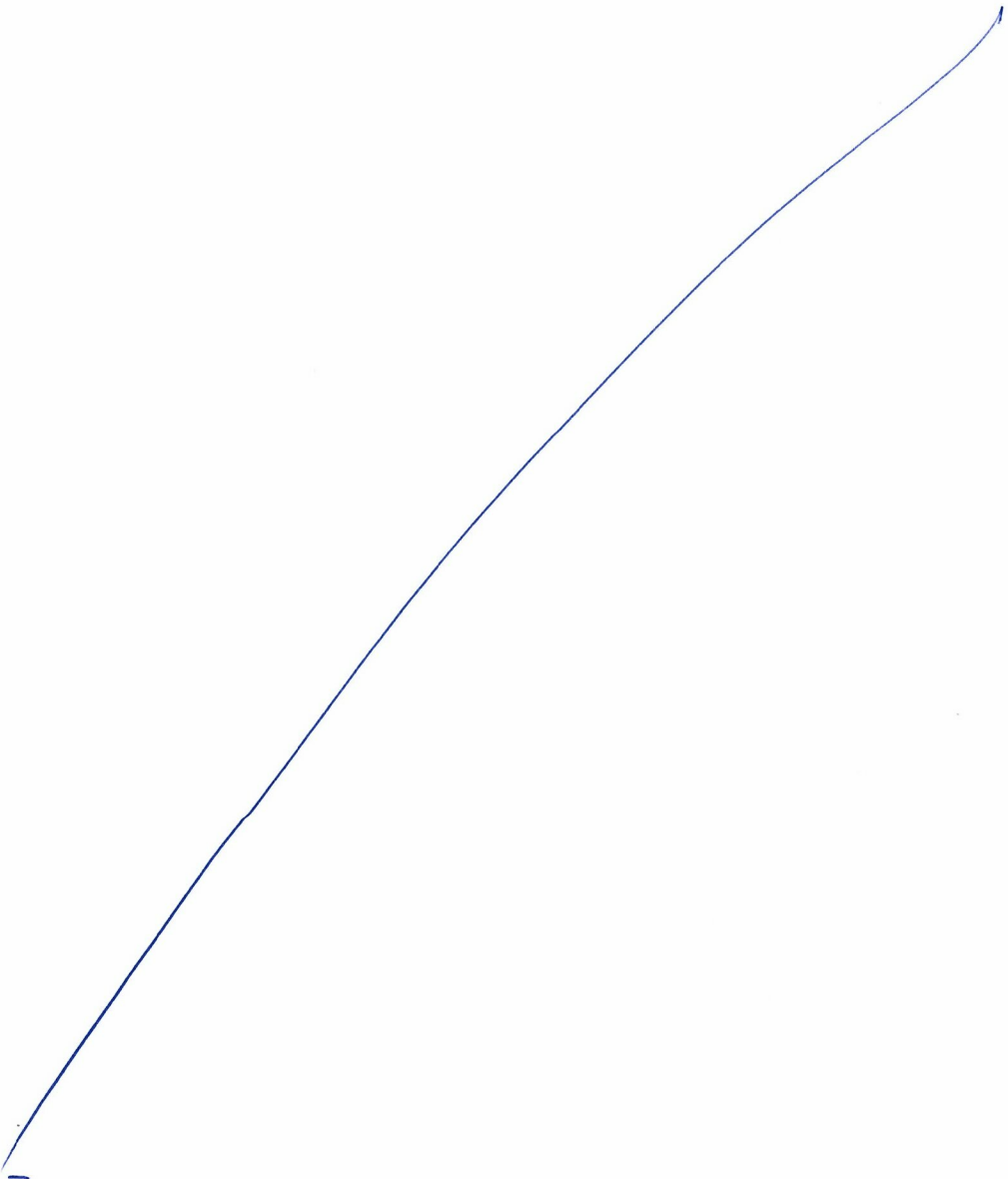

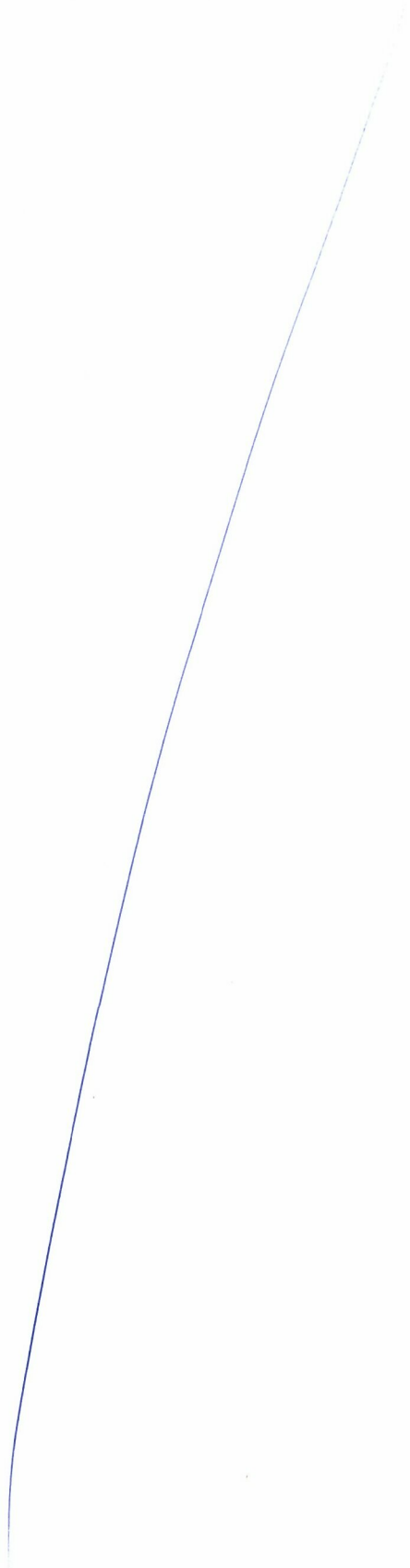

1. INTRODUCTION

Only Four participants/Bidders followed by Financial bids opening on 21st November, 2019 at 10:00 AM.
